- grant approval for 2011-2012 & 2012-2013 academic session for 60 admissions for the conduct of Ist & IInd year D.Pharm course.
- ii) allow 60 admissions for 2012-2013 academic session subject to submission of affiliation fee per annum to the PCI within the stipulated time period.
- 83. It was further decided to inspect the institution for considering final approval u/s 12 of the Pharmacy Act, 1948 on receipt of an undertaking on duly attested affidavit from an institution to

When the students are in the final year B.Pharm an inspection will be conducted by PCI for consideration approval of B.Pharm course u/s 12 of the Pharmacy Act for the purpose of registration as pharmacist. It is the responsibility of the institution to apply in the prescribed SIF of to PCI before 15th September every year alongwith complete documents.
